Foreword by pro-manchester Chair Alison Loveday



At the end of the 2023 review, Danny Simpson, the then pro-manchester Chair commented that his view was "optimistically but cautiously confident for 2024".

The general election and change of government was anticipated, and there was a positive desire for change in many quarters. The arrival of the Labour government in July 2024 came with promises of growth in the economy but unfortunately this appears to remain stubbornly out of reach. Rachel Reeves's budget in October 2024 was firmly pitched with this in mind but the reception from business leaders has been mixed, particularly around the increase in national insurance and national minimum wage.

Despite all this, the North West and Greater Manchester in particular, have bucked the national trend and delivered real growth, with calls from our Mayor Andy Burnham for the government to continue to support that growth. The increasing headcount that is necessary to support that growth is evident, and it's particularly pleasing to see this is notable in the highest salary bracket. This is supportive of the narrative that high-value jobs are here in the North West, and there's no longer any need to go South to find the same. Anecdotally, there is also a growing trend of individuals choosing to move to the North West, given its vibrancy and much enhanced quality of life.

Against this backdrop, what does the 2024 review tell us?

The uncertain global outlook, inflation and interest rates had an impact on deals, the volume of which was lower than anticipated, with deals also taking longer to deliver.

What is very pleasing to see though is the consistent growth in the number of deals being delivered by our corporate finance professionals-with an increase from 1270 deals in 2023 to 1593 deals in 2024, which involved either a Manchester business or a Manchester adviser.

As a region, we are particularly strong in the tech and professional services sectors but hospitality and leisure are also on the rise - despite challenges in these sectors, as are health and childcare.

The US was the most active acquirer of North West assets in 2024, and it was also the most targeted location for North West businesses seeking growth opportunities overseas. It will thus be interesting to see how 2025 evolves, given statements made by President Trump which have created fears of tariffs and trade wars which have already impacted the financial markets.

It will no doubt be a busy year and we look forward to the deal community delivering the pipeline of trade and PE deals that are "waiting in the wings", assisted by the welcome stability of interest rates.

Forward by the Corporate Finance Committee

As a Corporate Finance Committee we reflect the breadth of the deals community, bringing together expertise across mid market and large cap CF lead advisors, due diligence, Private Equity, law, debt and recruitment. We've come together to reflect on our sense of the Greater Manchester deals market over the last 12 months and looking forward to the year ahead.

The market during 2024 has had its challenges with inflationary pressures, interest rates, political change and geopolitical uncertainty impacting trading in a variety of sectors. A combination of these factors has depressed deal volumes over the last 12 months and generally deals have taken longer to complete with more in depth due diligence needed and aborted deals due to delays or due diligence uncovering key risks, particularly tax risks.

In July 2024 we saw Labour winning a big majority in the general election and a highly anticipated budget announced on 30 October 2024. Entrepreneurs were anticipating large rises in CGT which led to a flurry of deals completing in the run up to the October budget. Whilst there was a slight air of relief that CGT wasn't raised as much as entrepreneurs had expected, the unexpected changes to National Insurance and National Minimum Wage has not been received well by business leaders and will likely impact profitability and forecasts which could result in deals stalling.

That being said, businesses do not stand still and continue to be ambitious and this has meant that for many in the deals community their pipeline is strong for 2025 for both trade and PE deals and so the market in terms of deal volumes is likely to be stronger than 2024 with cautious optimism for increased deal flow during 2025.

The expectation gap between buyers and sellers has been narrowing, which is natural as deal volumes increase and there are more examples in the market to draw from. Further, there is a general consensus that the uncertainty over the last couple of years has enabled PE to spend their time well, bolstering their portfolio companies not only via bolt-ons but through investment in integration/ rightsizing etc., in addition to the availability of debt improving.

An indicator of growth and deal optimism can be seen in recruitment volumes, and stats shared from Axon Moore across 2023 and 2024 have shown a 23% increase in senior placements (salaries c. £80,000) which matches the trend of increased volumes of deals, as we would expect to see more Senior Hires in a busier market and that was definitely the case in 2024.

Tech and professional services sectors led the charge with regards to hiring, fuelled by increased investor activity and a strong appetite for growth. However, we also saw increased levels of hiring across the hospitality and leisure sectors, despite ongoing challenges in these industries, several prominent leisure-based businesses made strategic investments to bolster their financial leadership, signalling confidence and ambition for future growth.

The only thing we can be sure of as 2025 unfolds is that Manchester will continue to be a highly active place to do deals and we look forward to seeing stories of triumph from businesses across Greater Manchester.

Analysis – 2024 Review

pro-manchester, in collaboration with Experian MarketIQ, is delighted to present you with its Annual Corporate Finance Deals Review for 2024. This report aims to provide valuable insights into the activities of Manchester's corporate finance advisory community by examining the deals involving Manchester-based advisers. It also highlights adviser and deal activity across the North West.

Our latest analysis reveals that 2024 was another year of consistent growth for the region's corporate finance professionals. A total of 1,593 deals were completed involving either a Manchester business or a Manchester adviser, compared to 1,270 in 2023. The overall value remained largely stable, with a total of £20.7bn in 2024 compared to £21.9bn in 2023. Of the deals announced, 33% involved a North West acquirer, while 49% targeted a North West-based entity. This compares to 36% and 46% respectively for 2023. October 2024 stood out as one of the busiest months on record, reflecting a broader trend across the UK as companies rushed to finalise deals ahead of budget changes concerning capital gains tax and carried interest rules.

Deals in the sub-£10m price range saw a 20% decline in both volume and value compared to 2023. Conversely, the midmarket demonstrated robust growth, with deal numbers rising from 66 in 2023 to 79 in 2024, and values increasing by 51% from £1.9bn to £2.8bn. High-value deals experienced mixed results: large cap deals fell by 12% in volume but maintained their value, while mega deals dropped by 40% in volume and 6% in value.

Despite declines in sub-£10m deals and high-value transactions, the overall stability in deal values indicates a resilient market. The sustained value of large cap deals underscores ongoing confidence in substantial investments, while the modest decrease in mega deal values suggests a cautious yet not overly pessimistic outlook among the largest market players.

2025 Outlook

As interest rates stabilise, the increased opportunities for strategic borrowing to fund acquisitions are expected to drive deal-making activity.

The recent changes to the Takeover Code, effective from early February, may have significant implications by narrowing the scope of companies to which the Code applies.

Furthermore, the adoption of AI will continue to revolutionise the deal-making process at every stage. As a strategic asset, AI supports faster decision-making, providing firms with a competitive edge in a rapidly evolving market.

North West Insights

With the North West market experiencing another year of consistent growth, and an expanding network of adviser and funders, we reviewed some of the regions' key deals over the past 12 months.

Acquisitions accounted for 68% of the activity, with companies seeking funding to support growth at various stages represented an additional 12% of deal activity.

The number of companies transitioning to an employeeowned model increased from 21 deals in 2023 to 40 last year, with management-led transactions rising from 54 to 82.

Notable headline deals included the acquisition by Spanish energy company Iberdrola of 88% of Electricity North West, the Stockport-based owner of the electricity distribution network for North West England, for a total value, including debt, of €5bn. Another significant transaction was the £4bn buy-out of Manchester-based smart meter and energy management company Calisen by EQT and GIC, highlighting the confidence major global investors have in the UK's energy industry. Additionally, US private equity firm KPS Capital Partners agreed to pay £1.4bn for INEOS Composites, a company renowned for its production of plastic composites used in a wide range of applications across global markets.

Several of the region's highly acquisitive companies continued their expansion through acquisitions. Lymm-based Kids Planet Day Nurseries completed 22 acquisitions during the year, including the January acquisition of Springfield Day Nurseries and Dragons Camp holiday club, marking its entry into the Welsh market, and the August acquisition of Hollies Day Nurseries, taking it past the 200-nurseries mark. Perspective Financial Group was involved in 20 deals in 2024, making it the second most acquisitive buyer in the North West. Additionally, optician chain Hakim Group, backed by Seas Capital, expanded its portfolio with 19 further acquisitions.

The USA was the most active acquirer of North West assets in 2024, with deals including the £200m acquisition of Stockport-based Takepayments by Global Payments of Atlanta, Georgia, and the acquisition by Dura Software, Texas, of Worsley-based Invosys. While most North West acquirers chose to acquire within the UK, the US was also the most targeted location for North West businesses seeking growth opportunities overseas. Standout deals included the acquisition by JD Sports of Hibbett Sports for £887m and Northwich-based Dechra Pharmaceuticals' acquisition of Invetx for £400.6m.

Legal Adviser Insights

In this review, we highlight some of the standout deals executed by the region's leading legal teams.

Demonstrating their extensive reach, teams from **Pinsent Masons** and **Eversheds** supported the £2.5bn acquisition by
Motor Fuel Group of 337 Morrisons petrol forecourts, a deal
outside of their home territory. A multi-office team from **Pinsent Masons** also supported Elevation Advisors on its
£207m acquisition of Berkley Care Group, in another out-oftown deal.

Addleshaw Goddard played a pivotal role in advising JD Sports on its US acquisition of Hibbett Sports, as well as supporting the Co-op's acquisition of Coventry Building Society.

Squire Patton Boggs assisted Highview Enterprises with a £300m investment and provided further support for a £150m investment for Independent Governance.

DLA Piper offered legal advice to Takepayments during its acquisition by Global Payments.

Mills & Reeve supported the Kids Planet acquisitions and advised Elite Dynamics on its £5m funding from BGF, with additional advice from **DTM Legal**.

JMW Solicitors advised Samson VTI UK on its £5m funding round and supported the sale of Alnwick Dental Practice for £900k, among several other deals.

Kuits advised on several deals during the year including Nationwide Fleet Installations' acquisition of Avian Fleet, and OBI's acquisition of the BE Group's Agency Services Business pro-manchester Corporate Finance Review **TLT** supported Security Plus in its takeover by RMS Cash Solutions, while **Pannone Corporate** advised Bestplate Holding on its acquisition by Hills Group International.

DWF's North West team provided counsel to CMAC Group on its £80.2 million acquisition by CityFleet Networks.

Shoosmiths advised Indian client PI Industries on the £32.8m acquisition of Plant Health Care, an AIM-listed company that subsequently delisted.

Hill Dickinson supported on the £11m placing undertaken by SysGroup, one of many deals the firm has been involved in.

Brabners advised the Omni Partners vehicle on the £31m acquisition of a majority stake in Compass CHC.

Gateley supported Cooper Parry in its £13.5m acquisition of the Thames Valley and Reading office of Haines Watts.

Manchester teams from **Browne Jacobson**, **Hill Dickinson**, **and Weightmans** advised on the BGF and DSW Ventures investment into Apex Engage.

Clarke Willmott's Manchester office worked on several deals throughout the year, including the acquisition of N&M Walkingshaw by Lloyd Motor Group.

Ward Hadaway advised on the management buy-out of Interior Door Systems, alongside a team from Hill Dickinson.

Financial Adviser Insights

Manchester's extensive network of advisers has once again demonstrated that the region remains a hub for M&A and private equity activity.

While there are too many deals to mention individually, here is a broad cross-section of the deals that have completed over the last 12 months.

UHY Hacker Young advised Inchcape on the £346m sale of its UK business to Group 1 Automotive of the USA.

Zeus Capital acted as adviser and joint broker to Accrol Group Holdings on its £130.8m offer from The Navigator Company, resulting in another listed company leaving the public markets.

BDO supported HSBC in a £70m refinancing for Alpine Fire Engineers, alongside Shawbrook Bank, and also advised MirrorWeb on its US\$63m takeover by Mainsail Partners.

PwC's Manchester team provided advice to LDC on its investment into 15below.

KPMG advised Abtech Consulting on its acquisition by Celnor Group, with additional support from **Addleshaw Goddard** and **Cortus Advisory**.

Grant Thornton supported the £22.5m acquisition of Victoria Plumbing by AHK Designs.

MHA advised Software Circle on it £16.7m loan facility from Shawbrook Bank.

Cortus Advisory advised Project Kent Bidco on the acquisitions of Riva Foods and Mother Riley's Bakery

RSM supported Focus 4 U on several acquisitions, including Cellular Solutions & Services Ltd for £15.2m, iPinnacle for £11.2m (alongside **K3 Capital** on the sell-side), and Midland Telecommunications Management for £9.7m.

Azets' Manchester office advised Isograph on its transition to German ownership through its acquisition by PeakAvenue, a Main Capital Partners portfolio company.

Benchmark supported Campfire Group on its acquisition by a Literacy Capital vehicle for £2m.

Cowgills advised Ice Global on its £7m acquisition by a Key Capital vehicle, with **RSM** and **Bermans** advised the buy-out vehicle.

Alvarez & Marsal provided support to Besseges in securing an investment from BGF, alongside **Gateley**, **Saffery** and **Squire Patton Boggs**.

FRP Advisory Trading advised the holding company of Phoenix Optical on its £6.75m acquisition by Gooch & Housego.

Hurst advised BGF on its £5m investment in Elite Dynamics.

Forvis Mazars support Q-Park UK on its acquisition of Britannia Parking Group.

Royce Peeling Green was one of several Manchester firms to advise on the acquisition of Abacus Cost Management by Contollo alongside **BBS Law** and **Cortus Advisory**.

Funder Insights

North West businesses continued to be a prime target for private equity and venture capital investment during 2024. Businesses at all stages of growth and across a range of sectors secured investments to fund acquisitions and growth strategies.

Noteworthy deals included £62m funding package from **HSBC** for Sykes Seafoods, comprising a £12m loan and a £50m ABL facility.

Palatine Private Equity realised its investment in Direct Tyre Management in a £55m deal which saw Caledonia Investments become majority owner. Palatine was advised by Gateley, PwC and Clearwater. Palatine also acquired BluprintX for £36.5m.

Maven Capital Partners disposed of its long-term investment in MirrorWeb, a US\$63m transaction which saw Mainsail Capital Partners become the new majority shareholder. MirrorWeb was advised by BDO, Squire Patton Boggs and DC Advisory.

Praetura supported the transition to employee ownership of Challenge Logistics for £25.8m providing an invoice discounting facility and asset finance facility. **Squire Patton Boggs** advised **Praetura**.

OakNorth provided an £18m to Hurstwood Holdings to fund three new residential housing schemes.

NorthEdge Capital sold its stake in Clearly Drinks to Supreme, in a £15m deal.

NatWest provided a £12m funding package to Horwich Farrelly.

Business Growth Fund and Mercia invested further funds into Locate Bio in a £9.2m oversubscribed funding round. BGF also invested £5m into Apex Engage, alongside participation from DSW Ventures.

YFM Equity Partners provided a £5m investment to Fuuse, a developer of EV charging software.

Santander supported Cocogreen (UK) with the provision of a £7.5m funding package.

Northern Gristone led a £5m funding round for Samson VTI UK (t/a Partful) with participation from Par Equity and Blumberg Capital.

Inflexion Private Equity sold its investment in DR&P in a £425m deal, as well as supporting portfolio company Celnor on its £4.9m acquisition of Aitken Laboratories.

LDC invested in Insurtech Uinsure, in a deal which also included bank facilities from **HSBC** and **Santander**.

Lloyds provided a £4m asset finance facility to Brit European Transport.

These are but a few of the many deals from across the North West that were reported in 2024, and with deals still being reported, it's clear the North West and its community of advisers and funders enjoyed another year of strong activity.
